ANNOUNCEMENT

This statement is made at the request of The Stock Exchange of Hong Kong Limited.

We have noted the recent decrease in the price and increase in the trading volume of the shares of Regent Pacific Group Limited (the "Company") and wish to state that we are not aware of any reasons for such movements save for the preliminary results announcement issued by the Company on 21 July 2005 with respect to its audited final results for the year ended 31 March 2005.

We confirm that there are no negotiations or agreements relating to intended acquisitions or realisations which are discloseable under rule 13.23, neither is the board (the "Board") of directors (the "Directors") of the Company aware of any matter discloseable under the general obligation imposed by rule 13.09, which is or may be of a price-sensitive nature, save for the announcements issued by the Company on 4 and 13 July 2005 with respect to (i) the execution of a cooperation agreement relating to the conditional acquisition of a company which is intending to establish a joint venture in the People's Republic of China and (ii) the mandatory capital reduction and share sale option agreement relating to Bridge Securities Co., Ltd (a 77.75% owned subsidiary of Bridge Investment Holding Limited, which is in turn a 40.2% owned associate of the Company).
